FIRE CONTROL ZONE REGULATION

Fire control zones

1 The following fire control zones are established for the purposes of closure orders under section 14 and fire control orders under section 21 of the *Forest and Prairie Protection Act*:

(a) Zone No. 1

Commencing at the southeast corner of section 5 of township 1, range 27, west of the 4th meridian; thence northerly along the east boundaries of the said section 5 and sections 8, 17, 20 and 29 of the said township to the northeast corner of the said section 29; thence westerly along the north boundaries of the said section 29 and 30 of the said township and sections 25 and 26 of township 1, range 28, west of the 4th meridian to the northwest corner of the said section 26; thence southerly along the west boundaries of the said section 26 and sections 23, 14, 11 and 2 of the said township 1, range 28, west of the 4th meridian to the southwest corner of the said section 2; thence easterly along the south boundaries of the said section 2 and 1 of the said township and sections 6 and 5 of township 1, range 27, west of the 4th meridian to the point of commencement.

(b) Zone No. 2

Commencing at the southeast corner of section 15 of township 3, range 30, west of the 4th meridian; thence northerly along the east boundaries of sections 15 and 22 to the northeast corner of the said section 22; thence westerly along the north boundary of the said section 22 to the northeast corner of section 21 of the said township; thence northerly along the east boundaries of sections 28 and 33 of the said township and the east boundaries of sections 4, 9 and 16 of township 4, range 30, west of the 4th meridian to the northeast corner of the said section 16; thence westerly along the north boundaries of sections 16 and 17 of the said township and the north boundary of section 13 of township 4, range 1, west of the 5th meridian to the northeast corner of section 14 of the said township; thence northerly along the east boundary of

section 23 of the said township to the northeast corner thereof; thence westerly along the north boundaries of sections 23 and 22 to the northeast corner of section 21 of the said township; thence northerly along the east boundaries of sections 28 and 33 of the said township and the east boundary of section 4 of township 5, range 1, west of the 5th meridian to the northeast corner of the said section 4; thence westerly along the north boundaries of sections 4 and 5 to the northeast corner of section 6 of the said township; thence northerly along the east boundary of section 7 of the said township to the northeast corner thereof; thence westerly along the north boundary of the said section 7 to the northeast corner of section 12 of township 5, range 2, west of the 5th meridian; thence northerly along the east boundary of section 13 of the said township to the northeast corner thereof; thence westerly along the north boundaries of sections 13, 14, 15 and 16 to the northeast corner of section 17 of the said township; thence northerly along the east boundaries of sections 20, 29 and 32 of the said township and the east boundaries of sections 5 and 8 of township 6, range 2, west of the 5th meridian to the northeast corner of the said section 8; thence westerly along the north boundaries of sections 8 and 7 of the said township and the north boundary of section 12 of township 6, range 3, west of the 5th meridian to the northeast corner of section 11 of the said township; thence northerly along the east boundaries of sections 14, 23 and 26 of the said township to the northeast corner of the said section 26; thence easterly along the north boundary of section 25 of the said township to the northeast corner thereof; thence northerly along the east boundary of range 3 to the northeast corner of township 7, range 3, west of the 5th meridian; thence westerly along the north boundary of section 36 to the northeast corner of section 35 of the said township; thence northerly along the east boundaries of sections 2, 11, 14, 23, 26 and 35 of townships 8 and 9, range 3, west of the 5th meridian and the east boundaries of sections 2, 11, 14, 23 and 26 of township 10, range 3, west of the 5th meridian to the intersection with the left bank of the Oldman River; thence easterly along the said left bank to its intersection with the north boundary of section 20 of township 10, range 2, west of the 5th meridian; thence easterly along the said north boundary of section 20, the north boundaries of sections 21, 22, 23 and 24 of the said township and the north boundaries of sections 19 and 20 of township 10, range 1, west of the 5th meridian to the northeast corner of the said section 20; thence southerly along the east boundaries of sections 20, 17, and 8 to the northeast corner of section 5 of the said township; thence

easterly along the north boundary of section 4 of the said township to the westerly limit of a road as shown on plan 1208 LK; thence southerly along the said westerly limit to the southerly limit of a road that intersects the said road in the northeast quarter of section 33 of township 9, range 1, west of the 5th meridian; thence easterly along the said road to its intersection with the east boundary of section 4 of township 10, range 1, west of the 5th meridian; thence southerly along the said east boundary of section 4, and the east boundaries of sections 33, 28, 21 and 16 of township 9, range 1, west of the 5th meridian to the northeast corner of section 9 of the said township; thence easterly along the north boundary of section 10 of the said township to the northerly boundary of a road as shown on plan no. 6481 BM; thence easterly along the northerly limit of the said road to its intersection with the north boundary of section 10 of the said township; thence easterly along the north boundary of the said section 10 to its intersection with the previously mentioned road; thence southeasterly and then southerly along the said southeasterly limit to its intersection with the easterly limit of a road as shown on plan No. 6377 I; thence southerly along the said easterly limit to its intersection with the northeasterly limit of a road as shown on plan no. 6385 BM; thence southerly along the said northeasterly limit and the easterly limit of the said road (6385 BM) to its intersection with the easterly limit of a road as shown on plan no. 6377 I; thence southerly and southeasterly along the easterly and northeasterly limits of the said road (6377 I) to its intersection with the northerly limit of the said road (6385 BM); thence easterly along the said northerly limit and southerly along the easterly limit of the said road (6385 BM) to its intersection with the northeasterly limit of a road as shown on the said plan No. 6377 I; thence southerly along the northeasterly and southeasterly limits of the said road (6377 I) to its intersection with the east boundary of section 2 of the said township 9, range 1, west of the 5th meridian; thence southerly along the said east boundary of section 2 and the east boundary of section 35 of township 8, range 1, west of the 5th meridian to the northeast corner of section 26 of the said township; thence easterly along the north boundary of section 25 of the said township; the north boundaries of fractional section 28, sections 27, 26 and 25 of township 8, range 30, west of the 4th meridian and the north boundary of section 30 of township 8, range 29, west of the 4th meridian to the northeast corner of the said section 30; thence northerly along the east boundary of section 31 of the said township and the east boundaries of sections 6, 7, 18 and 19 of township 9, range 29, west of

the 4th meridian to the northeast corner of the said section 19; thence easterly along the north boundaries of sections 20, 21 and 22 of the said township to the northeast corner of the said section 22; thence northerly along the east boundaries of sections 27 and 34 of the said township and the east boundaries of sections 3, 10 and 15 of township 10, range 29, west of the 4th meridian to the northeast corner of the said section 15; thence westerly along the north boundary of the said section 15 to the northeast corner of section 16 of the said township; thence northerly along the east boundary of section 21 of the said township to the northeast corner thereof; thence westerly along the north boundary of the said section 21 to the northeast corner of section 20 of the said township; thence northerly along the east boundaries of sections 29 and 32 of the said township to the north boundary of the said township 10; thence westerly along the said north boundary to its intersection with the southerly production of the east boundary of section 5 of township 11, range 29, west of the 4th meridian; thence northerly along the said production, the east boundary of the said section 5 and the east boundaries of sections 8, 17 and 20 of the said township to the northeast corner of the said section 20; thence westerly along the north boundary of the said section 20, the north boundary of section 19 of the said township and the north boundary of section 24 of township 11, range 30, west of the 4th meridian to the northeast corner of fractional section 23 of the said township; thence northerly along the east boundaries of fractional sections 26 and 35 of the said township to the northeast corner of the said section 35; thence westerly along the north boundary of township 11 to the northeast corner of township 11, range 1, west of the 5th meridian; thence northerly along the east boundary of township 12, range 1, west of the 5th meridian to the northeast corner of section 13 of the said township; thence easterly along the north boundaries of fractional section 14 and section 13 of township 12, range 30, west of the 4th meridian and the north boundary of section 18 of township 12, range 29, west of the 4th meridian to the northeast corner of the said section 18; thence northerly along the east boundaries of sections 19, 30 and 31 of the said township and the east boundaries of sections 6, 7, 18 and 19 of township 13, range 29, west of the 4th meridian to the northeast corner of the said section 19; thence westerly along the north boundary of the said section 19 to the northeast corner of section 24 of township 13, range 30, west of the 4th meridian; thence northerly along the east boundary of section 25 of the said township to the northeast corner of the said section 25; thence westerly along the north

boundary of the said section 25 and the north boundary of fractional section 26 of the said township to the northeast corner of section 25 of township 13, range 1, west of the 5th meridian; thence northerly along the east boundary of section 36 of the said township and the east boundaries of sections 1, 12, 13 and 24 of township 14, range 1, west of the 5th meridian to the northeast corner of the said section 24; thence westerly along the north boundary of the said section 24 and the north boundaries of sections 23 and 22 of the said township to the northeast corner of section 21 of the said township; thence northerly along the east boundaries of sections 28 and 33 of the said township and the east boundaries of sections 4, 9, 16, 21, 28 and 33 of township 15, range 1, west of the 5th meridian to the northeast corner of the said section 33 of township 15; thence westerly along the north boundary of the said township 15 to the northeast corner of section 33 of township 15, range 3, west of the 5th meridian; thence southerly along the east boundary of the said section 33 to the northeast corner of section 28 of the said township; thence easterly along the north boundary of section 27 of the said township to the northeast corner thereof; thence southerly along the east boundary of the said section 27 and the east boundaries of sections 22 and 15 to the intersection with the northerly limit of Secondary Highway No. 532; thence southwesterly along the said northerly limit to its intersection with northerly limit of the Forestry Trunk Road within township 14, range 4, west of the 5th meridian; thence westerly along the said northerly limit of the Forestry Trunk Road to its intersection with the height of land within township 14, range 5, west of the 5th meridian, separating the Highwood-Bow River and Upper Oldman River watersheds; thence westerly along the said height of land to its intersection with the east boundary of section 13 of township 14, range 6, west of the 5th meridian; thence southerly along the said east boundary of section 13 and the east boundaries of sections 12 and 1 of the said township to the northeast corner of township 13, range 6, west of the 5th meridian; thence westerly along the north boundary of the said township 13 to the Alberta-British Columbia boundary; thence southerly along the said Alberta-British Columbia boundary to its intersection with the north boundary of section 19 of township 8, range 5, west of the 5th meridian; thence easterly along the said north boundary of section 19 and the north boundaries of sections 20 and 21 of the said township to the northeast corner of the said section 21; thence northerly along the east boundary of section 28 of the said township to the northeast corner thereof; thence easterly along the north

boundary of section 27 of the said township to the northeast corner thereof; thence southerly along the east boundary of the said section 27 to the northeast corner of section 22 of the said township; thence easterly along the north boundaries of sections 23 and 24 of the said township and the north boundaries of section 19 and the west half of section 20 of township 8, range 4, west of the 5th meridian to the northeast corner of the said west half of section 20; thence southerly along the east boundary of the said west half to the north boundary of section 17 of the said township; thence easterly along the said north boundary and the north boundaries of sections 16 and 15 of the said township to the northeast corner of the said section 15; thence southerly along the east boundary of the said section 15 to the northeast corner of section 10 of the said township; thence easterly along the north boundaries of sections 11 and 12 of the said township and the north boundaries of sections 7 and 8 of township 8, range 3, west of the 5th meridian to the northeast corner of the said section 8; thence southerly along the east boundary of the said section 8 to the northeast corner of section 5 of the said township; thence easterly along the north boundaries of sections 4 and 3 of the said township to the northeast corner of the said section 3; thence southerly along the east boundary of the said section 3 and the east boundaries of sections 34 and 27 of township 7, range 3, west of the 5th meridian to the northeast corner of section 22 of the said township; thence easterly along the north boundary of section 23 of the said township to the northeast corner thereof; thence southerly along the east boundary of the said section 23 to the northeast corner of section 14 of the said township; thence westerly along the north boundary of the said section 14 to the northeast corner of section 15 of the said township; thence southerly along the east boundary of the said section 15 and the east boundary of section 10 of the said township to its intersection with the right bank of the Crowsnest River; thence easterly along the said right bank of the Crowsnest River to its intersection with the east boundary of the northwest quarter of section 11 of the said township; thence northerly along the said east boundary to the north boundary of section 11 of the said township; thence easterly along the said north boundary of section 11 to the northeast corner thereof; thence southerly along the east boundary of the said section 11 to the northeast corner of section 2 of the said township; thence westerly along the north boundary of the said section 2 and the north boundary of section 3 of the said township to the northeast corner of section 4 of the said township; thence southerly along the east boundary of the said section 4 and

the east boundary of section 33 of township 6, range 3, west of the 5th meridian to the northeast corner of section 28 of the said township; thence westerly along the north boundary of the said section 28 and the north boundary of section 29 of the said township to the northeast corner of section 30 of the said township; thence southerly along the east boundary of the said section 30 to the northeast corner of section 19 of the said township; thence westerly along the north boundary of the said section 19 and the north boundary of section 24 of township 6, range 4, west of the 5th meridian to the northeast corner of section 23 of the said township; thence northerly along the east boundaries of sections 26 and 35 of the said township to the northeast corner of the said section 35; thence westerly along the north boundary of township 6 to its intersection with the southerly production of the east boundary of section 5 of township 7, range 4, west of the 5th meridian; thence northerly along the said east boundary of section 5 and the east boundaries of sections 8 and 17 of the said township to the northeast corner of the said section 17; thence westerly along the north boundary of the said section 17, the north boundary of section 18 of the said township and the north boundary of section 13 of township 7, range 5, west of the 5th meridian to the northeast corner of section 14 of the said township; thence southerly along the east boundary of the said section 14 to the northeast corner of section 11 of the said township; thence westerly along the north boundary of the said section 11 to the Alberta-British Columbia boundary; thence southeasterly along the said Alberta-British Columbia boundary to its intersection with the north boundary of Waterton Lakes National Park; thence easterly along the said north boundary of Waterton Lakes National Park to its intersection with the west boundary of section 15 of township 3, range 30, west of the 4th meridian; thence southerly along the said west boundary to the southwest corner of the said section 15; thence easterly along the south boundary of the said section 15 to the southeast corner thereof, this being the point of commencement.

(c) Zone No. 3

Commencing at the intersection of the Alberta-British Columbia boundary with the north boundary of section 19 of township 8, range 5, west of the 5th meridian; thence easterly along the said north boundary of section 19 and the north boundaries of sections 20 and 21 of the said township to the northeast corner of the said section 21; thence northerly along the east boundary of section 28 of

the said township to the northeast corner thereof; thence easterly along the north boundary of section 27 of the said township to the northeast corner thereof; thence southerly along the east boundary of the said section 27 to the northeast corner of section 22 of the said township; thence easterly along the north boundaries of sections 23 and 24 of the said township and the north boundaries of section 19 and the west half of section 20 of township 8, range 4, west of the 5th meridian to the northeast corner of the said west half of section 20; thence southerly along the east boundary of the said west half to the north boundary of section 17 of the said township; thence easterly along the said north boundary and the north boundaries of sections 16 and 15 of the said township to the northeast corner of the said section 15; thence southerly along the east boundary of the said section 15 to the northeast corner of section 10 of the said township; thence easterly along the north boundaries of sections 11 and 12 of the said township and the north boundaries of sections 7 and 8 of township 8, range 3, west of the 5th meridian to the northeast corner of the said section 8; thence southerly along the east boundary of the said section 8 to the northeast corner of section 5 of the said township; thence easterly along the north boundaries of sections 4 and 3 of the said township to the northeast corner of the said section 3; thence southerly along the east boundary of the said section 3 and the east boundaries of sections 34 and 27 of township 7, range 3, west of the 5th meridian to the northeast corner of section 22 of the said township; thence easterly along the north boundary of section 23 of the said township to the northeast corner thereof; thence southerly along the east boundary of the said section 23 to the northeast corner of section 14 of the said township; thence westerly along the north boundary of the said section 14 to the northeast corner of section 15 of the said township; thence southerly along the east boundary of the said section 15 and the east boundary of section 10 of the said township to its intersection with the right bank of the Crowsnest River; thence easterly along the said right bank of the Crowsnest River to its intersection with the east boundary of the northwest quarter of section 11 of the said township; thence northerly along the said east boundary to the north boundary of the said section 11; thence easterly along the said north boundary of section 11 to the northeast corner thereof; thence southerly along the east boundary of the said section 11 to the northeast corner of section 2 of the said township; thence westerly along the north boundary of the said section 2 and the north boundary of section 3 of the said township to the northeast corner of section 4 of the said township; thence southerly

along the east boundary of the said section 4 and the east boundary of section 33 of township 6, range 3, west of the 5th meridian to the northeast corner of section 28 of the said township; thence westerly along the north boundary of the said section 28 and the north boundary of section 29 of the said township to the northeast corner of section 30 of the said township; thence southerly along the east boundary of the said section 30 to the northeast corner of section 19 of the said township; thence westerly along the north boundary of the said section 19 and the north boundary of section 24 of township 6, range 4, west of the 5th meridian to the northeast corner of section 23 of the said township; thence northerly along the east boundaries of sections 26 and 35 of the said township to the northeast corner of the said section 35; thence westerly along the north boundary of township 6 to its intersection with the southerly production of the east boundary of section 5 of township 7, range 4, west of the 5th meridian; thence northerly along the said east boundary of section 5 and the east boundaries of sections 8 and 17 of the said township to the northeast corner of the said section 17; thence westerly along the north boundary of the said section 17, the north boundary of section 18 of the said township and the north boundary of section 13 of township 7, range 5, west of the 5th meridian to the northeast corner of section 14 of the said township; thence southerly along the east boundary of the said section 14 to the northeast corner of section 11 of the said township; thence westerly along the north boundary of the said section 11 to its intersection with the Alberta-British Columbia boundary; thence northerly along the said Alberta-British Columbia boundary to its intersection with the north boundary of section 19 of township 8, range 5, west of the 5th meridian, this being the point of commencement.

(d) Zone No. 4

Commencing at the northeast corner of section 34 of township 15, range 3, west of the 5th meridian; thence northerly along the east boundary of section 3 of township 16, range 3, west of the 5th meridian to the northeast corner thereof; thence westerly along the north boundary of the said section 3 to the northeast corner of section 4 of the said township; thence northerly along the east boundaries of sections 9, 16, 21, 28 and 33 of the said township to the northeast corner of the said section 33; thence westerly along north boundary of township 16 to the northeast corner of section 35 of township 16, range 4, west of the 5th meridian; thence northerly along the east boundaries of sections 2 and 11 of township 17, range 4,

west of the 5th meridian to the northeast corner of the said section 11; thence easterly along the north boundary of section 12 of the said township to the northeast corner thereof; thence northerly along the east boundaries of sections 13, 24 and the southeast quarter of section 25 of the said township to the northeast corner of the said southeast quarter of section 25; thence westerly along the north boundary of the said southeast quarter to its intersection with the left bank of the Highwood River; thence southwesterly along the said left bank of the Highwood River to its intersection with the east boundary of section 14 of the said township; thence northerly along the said east boundary of section 14, the east boundaries of sections 23, 26 and 35 of the said township and the east boundaries of sections 2, 11, 14, 23, 26 and 35 of township 18, range 4, west of the 5th meridian to the northeast corner of the said section 35 of township 18, range 4, west of the 5th meridian; thence westerly along the north boundary of the said section 35 and the north boundary of section 34 of the said township to the northeast corner of section 33 of the said township; thence southerly along the east boundary of the said section 33 and the east boundary of section 28 of the said township to the northeast corner of section 21 of the said township; thence westerly along the north boundary of the said section 21 and the north boundary of section 20 of the said township to the northeast corner of section 19 of the said township; thence southerly along the east boundary of the said section 19, the east boundaries of sections 18, 7 and 6 of the said township and the east boundaries of sections 31 and 30 of township 17, range 4, west of the 5th meridian to the northeast corner of section 19 of the said township; thence easterly along the north boundary of section 20 of the said township to the northeast corner thereof; thence southerly along the east boundaries of sections 20, 17 and 8 of the said township to the northeast corner of section 5 of the said township; thence westerly along the north boundary of the said section 5 to the northeast corner of section 6 of the said township; thence southerly along the east boundary of the said section 6 to the northeast of section 31 of township 16, range 4, west of the 5th meridian; thence easterly along the north boundary of section 32 of the said township to the northeast corner thereof; thence southerly along the east boundaries of sections 32 and 29 to the northeast corner of section 20 of the said township; thence easterly along the north boundaries of sections 21 and 22 of the said township to the northeast corner of the said section 22; thence southerly along the east boundaries of sections 22, 15 and 10 of the said township to the northeast corner of

section 3 of the said township; thence easterly along the north boundaries of sections 2 and 1 of the said township and the north boundary of section 6 of township 16, range 3, west of the 5th meridian to the northeast corner of the said section 6; thence southerly along the east boundary of the said section 6 to the northeast corner of section 31 of township 15, range 3, west of the 5th meridian; thence easterly along the north boundaries of sections 32, 33 and 34 of the said township to the northeast corner of the said section 34, this being the point of commencement.

(e) Zone No. 5

Commencing at the northeast corner of section 33 of township 15, range 3, west of the 5th meridian; thence southerly along the east boundary of the said section 33 to the northeast corner of section 28 of the said township; thence easterly along the north boundary of section 27 of the said township to the northeast corner thereof; thence southerly along the east boundary of the said section 27 and the east boundaries of sections 22 and 15 of the said township to the intersection with the north limit of Secondary Highway No. 532; thence southwesterly along the said north limit of Secondary Highway No. 532 to its intersection with the north limit of the Forestry Trunk Road in township 14, range 4, west of the 5th meridian; thence westerly along the said north limit of the Forestry Trunk Road to its intersection with the height of land in township 14, range 5, west of the 5th meridian separating the Highwood-Bow River and Upper Oldman River watersheds; thence westerly along the said height of land to its intersection with the east boundary of section 13 of township 14, range 6, west of the 5th meridian; thence southerly along the said east boundary of section 13 and the east boundaries of sections 12 and 1 of the said township to the northeast corner of township 13, range 6, west of the 5th meridian; thence westerly along the north boundary of township 13 to the Alberta-British Columbia boundary; thence northwesterly along the said Alberta-British Columbia boundary to its intersection with the east boundary of Banff National Park in township 20, range 10, west of the 5th meridian; thence northerly along the said east boundary of Banff National Park to its intersection with the west boundary of the Town of Canmore in section 14, township 25, range 11, west of the 5th meridian; thence southeasterly along the said west boundary of the Town of Canmore to its intersection with the right bank of the Bow River in section 6 of township 25, range 10, west of the 5th meridian; thence southerly along the said right bank of the Bow River to its

(i) Zone No. 9

(j) Zone No. 10

This Fire Control Zone is coincident with the White Goat Wilderness Area as designated under the Wilderness Areas, Ecological Reserves and Natural Areas Act, and is more particularly described as follows.
