Provincial Offences Procedure Act

PROCEDURES (PUBLIC LANDS ADMINISTRATION) AMENDMENT REGULATION

1 The *Procedures Regulation* (AR 233/89) is amended by this Regulation.

2 Section 2 is amended by adding the following after clause (r.1):

(r.11) *Public Lands Administration Regulation* for which a specified penalty is set out in Schedule 2;

3 Schedule 2 is amended

(a) by repealing Parts 4 and 4.1;

(b) by adding the following after Part 20.01:

Part 20.02 The Regulations Under the Public Lands Act

Public Lands Administration Regulation

1 The specified penalty payable in respect of a contravention of a provision of the *Public Lands Administration Regulation* shown in Column 1 is the amount shown in Column 2 in respect of that provision.

2 An "X" in Column 3 indicates that proceedings in respect of the offence may be commenced by a violation ticket issued under either Part 2 or Part 3 of the *Provincial Offences Procedure Act*.
