



*The Traffic Safety Act, which came into force May 20, 2003, is a consolidated approach to road safety, providing clarity for all road users such as driver instructors, law enforcement and the public. The new legislation replaces six Acts and 64 Regulations (including Highway Traffic Act, Motor Vehicle Administration Act, Motor Transport Act and Off-Highway Vehicle Act) with one Act and 30 Regulations.*
