Historical Legislation

The Wills and Succession Act repealed four acts: Dependants Relief Act (RSA 2000 cD-10.5); Intestate Succession Act (RSA 2000 cI-10); Survivorship Act (RSA 2000 cS-28); and the Wills Act (RSA 2000 cW-12).

Some individuals using this Surrogate Rules and Forms Package may require access to these repealed acts, if the date of death occurred before the Wills and Succession Act came into force on February 1, 2012.
